The Association of European Coeliac Societies (AOECS) is a not for profit umbrella organization of 35 European national coeliac societies. It owns and operates a gluten-free certification scheme that is internationally-recognized by its Crossed Grain symbol.

Food manufacturers and retailers are able to use this symbol if they meet the AOECS Standard for Gluten-free Foods. To simplify this process without compromising safety, Coeliac UK, an AOECS member, and SGS have joined forces to create a complete stand-alone audit against the requirements of the AOECS Standard for Gluten-free Foods.

CROSSED GRAIN CERTIFICATION: THE ESSENTIALS

Three different types of license are available depending upon the location of the food company: UK, mainland Europe, and globally. However, all foodstuffs bearing the Crossed Grain symbol have to comply with all requirements of the AOECS Standard for Gluten-free Foods, including:

- End-products must contain 20 mg/kg (parts per million – or “ppm”) or less of gluten
- Only products with multiple ingredients, or processed products (e.g. fruit bars) can be certified
- Products composed of a single ingredient, or products that are unprocessed (e.g. fresh fruit) cannot be certified
- Facilities that manufacture AOECS-certified products must be audited annually (this can be done as a stand-alone assessment through the Coeliac UK/SGS audit program, or in combination with a recognized food safety audit, such as the voluntary bolt-on module (Module 12) developed by BRC in partnership with AOECS)
- Manufacturers must use accredited laboratories to conduct finished product testing each year

The annual licence fee varies according to the turnover and exports of the gluten-free products certified as part of the licensing agreement. Organizations are allowed to add more products to their licence at any stage in the year, without extra charge.

SIX STEPS TO CROSSED GRAIN CERTIFICATION

1. Complete the online form free of charge (www.coeliac.org.uk/crossed-grain-symbol) or contact licensing@coeliac.org.uk.

Coeliac UK will calculate your annual licence fee and advise on next steps

2. Prepare your facility for an onsite audit by conducting a self-assessment or gap analysis (or ask SGS to do this for you)
3. Book your audit with SGS and arrange for your products to be tested for gluten content
4. When you pass your audit, SGS will issue a certificate of compliance against the AOECS standard
5. Send your audit certificate to Coeliac UK by emailing licensing@coeliac.org.uk as part of the documentation required to complete your licence application for use of the Crossed Grain symbol
6. Maintain your Crossed Grain symbol certification by planning for your facility’s annual audits and conducting the necessary product testing
