- Plan, conduct, report and follow up an audit of a BCMS to establish conformity with ISO 22301:2012 and in accordance with ISO 19011 and ISO/IEC 17021 where appropriate

Learners will need to demonstrate acceptable performance in these areas to complete the course successfully.
