PROGRAM MANDATED BY	Saudi Food and Drug Authority (SFDA)
IMPLEMENTATION DATE	01.01.2020
PROGRAM OBJECTIVES	Assess and verify compliance of Food and Beverages that will be exported to the Kingdom of Saudi Arabia, in accordance with the regulations, rules, specifications and conditions approved by SFDA.
VERIFICATION PROCESS	 Verify the conformity of the goods to the updated SFDA standards/technical regulations and requirements Perform physical inspection on the products Perform physical inspection of the container/ transportation medium of the goods in terms of physical condition and hygiene Along with physical inspection sample collection is carried out from each container/transportation medium of shipment. The sampling process will follow specific product standards/SFDA requirements. Samples are marked with SGS reference/sample sticker (the sticker serial number will be considered as the 'reference number') and transferred to sterile single-use bags Sampling for testing will be done based on the risk of the product category. Batch-wise testing is mandatory for all the consignments Seal the carton from which samples are removed using SGS Tape Fill in the 'sampling receipt' form which includes full details of sample collected, seal number, etc. Every batch detail included in the consignment is to be captured along with the production expiry and updated in the inspection report



	 Attaching copy of sampling receipt to the inspection report Attaching copy of the sample-receipt with the collected sample which serves as reference document for the testing laboratory Handover samples to client for testing. Testing is to be carried out at a ISO/IEC 17025 accredited laboratory On availability of passing test results, SGS inspector supervises container loading, ensures only batches examined and captured during initial inspection is loaded and seals the container Issuance of CoC (Certificate of Conformity). The CoC shall include: Full reference and traceability to samples drawn (sample reference number) for testing Seal numbers (each container) Issue NNR (Non-negotiable report) if the test reports are found failing Provide SFDA with daily reports
ROUTES	Route A: Non-registered products – It involves pre-shipment inspection and pre-shipment testing of products. Physical inspection carried out to verify the labeling/marking, storage, and other visual verification.
APPROVED LABORATORY	Testing to be as per SFDA requirements from SFDA approved labs / ISO/IEC 17025 accredited labs only
DOCUMENTATION	 Exporter submits to SGS the following documents: Request for Certification and Declaration of Conformity Commercial Invoice Documents: Ingredient list with concentrations, Certificate of Analysis/Test report {batch-wise}, product labels/artworks, Hygiene certificate SFDA Registration number for product Test reports from SFDA-approved labs / ISO/IEC 17025 accredited labs only Company's Quality Management System documents (ISO 9001, ISO 22000, GMP, HACCP, any FSMS certification or likewise) Halal Certificate from SFDA-approved bodies (as applicable) Slaughter Certificate from SFDA-approved bodies (as applicable) Certificate of Origin (as applicable) Health Certificate (as applicable) Establishment Registration (Mandatory for Fishery products, poultry products, meat products, and honey products, for Egypt-origin products – frozen and processed vegetables and fruits, milk and milk products)
CERTIFICATE	A Certificate of Conformity (CoC) is issued to evidence the compliance of the shipment.



	 It is also required that all food & beverage products shall have SFDA Registration Numbers available Establishment Registration is mandatory for establishments exporting meat, fishery products, and chicken meats. Also, starting from 1st June 2021, Establishment registration is mandatory for honey products and also for Egypt-origin products – frozen and processed vegetables and fruits, milk and milk products
