

Food safety

ISO 22000 – Food Safety Management Systems

ISO 22000 is an international certification standard that defines the requirements for effective food safety management systems. It can be used by organizations throughout the supply chain – from farmers and ingredient suppliers, to food services, processors, transportation and storage companies, retailers and packaging companies. BRC – British Retail Consortium

The British Retail Consortium (BRC) is a UK trade organisation that represents the interests of UK retailers. Setting out the requirements for the supply of safe and legal consumer products of consistent quality, this standard covers the vast majority of non-food products and identifies how to determine the product group into which a product should be placed, and defines a wide range of audit requirements. Meeting the requirements of the BRC's Global Standards demonstrates a company's competence in maintaining product safety, quality and legality.

HACCP – Hazard Analysis Critical Control Point

Hazard Analysis and Critical Control Points (HACCP) is an international standard defining the requirements of a safe food management system. The HACCP system helps organisations focus on the hazards that affect food safety / food hygiene and the systematic identification, setting and implementation of critical control limits at critical control points during the food production process.

US FSMA – Food Safety Modernization Act

The US Food and Drug Administration (FDA) Food Safety Modernization Act (FSMA) shifts the industry's focus away from responding to contamination events. Such a step-change requires the updating and alignment of policies, processes and their implementation, to meet the FDA's seven foundational rules for FSMA compliance. If you have food businesses with the US, it must comply with the FSMA.

Medical device

ISO 13485 – Quality Management Systems For Medical Devices

ISO 13485 is a standard specific to Medical Device Quality Management System that supplements the ISO 9001 standard. Some of the additional requirements relate to design and process controls, special processes, traceability, record retention and regulatory actions, which are particularly critical to the medical devices industry. ISO 13485 is applicable to all manufacturers and providers of medical devices, components, contract services and distributors of medical devices.

ISO 14971 – Medical Device Risk Management

ISO 14971 is a standard specific to risk management for the Medical Devices industry. ISO 14971 enables you to demonstrate how risk management applies to the product lifecycle and how to effectively implement the objectives of risk management process.

LRP (Local Responsible Person) – applicable to Hong Kong

There is increasing concern of local adverse incidents and complaints related to medical devices, which had aroused the general public awareness to the functionalities and reliability of the medical devices.

The Hong Kong Government is examining the safety and health risk of the medical devices and planning introduce a new legislation to deal with the issue of control over the registration. PIC/S Good Manufacturing Practice (GMP)

The Pharmaceutical Inspection Co-operation Scheme (PIC/S) was firstly established in 1995 and is well recognized as an informal co-operative arrangement between Regulatory Authorities of Good Manufacturing Practice (GMP) among different countries which aimed to harmonize the inspection procedures worldwide. Global markets and international manufacture and supply of both raw materials and active pharmaceutical ingredients increase the complexity of supply chains. Addressing GMP regulations effectively across international borders is easily facilitated by our network of local experts.


Global Reporting Initiative (GRI)
