## PRE-SHIPMENT INSPECTION SERVICES

PPC – Pre-Production Check
 It ensures that material, component,
 label specification, user manual,
 and other important parameters are
 checked before processing and to
 eliminate the risk of non-compliance
 to product specification due to
 poor planning and/or use of sub standard materials and/or inadequate
 manufacturing processes.

- IPC Initial Production Check It is conducted at an early stage of production when the first batch of product has been produced, to ascertain conformity to basic product specification.
- DUPRO During Production
   It is conducted when 30 50% of
   the total order quantity is available
   in boxes to ascertain that initial
   discrepancies have been rectified and
   to check that product quality meets
   the required specifications.
- FRI Final Random Inspection It is the statistical, visual inspection at the end of production before shipment, in principle when 100% is produced.
- LS Loading Supervision
   This service ensures that the
   inspected and released consignment
   is shipped without tampering to
   the buyer.
- II Informative Self Inspection In this service, inspection is being conducted on the request of local manufacturers/exporters to assess

their quality before offering the same to their international buyers in accordance to international inspection standards.

#### MAN-MONTH INSPECTION SERVICES

In this service team experts are deputed at the factory in order to perform a thorough inspection/quality assessment as per the mentioned customer(s) on monthly basis. Inspection findings along with photographs and graphical representations are shared/ presented to the top management of the company on daily basis, weekly basis, and at the end of the month.
