


Our TransitNet platform is unique and provides a faster, easier and a more efficient way to get your cargo through multiple border crossings.


Ensuring product compliance – supporting manufacturers import & export needs

Product Conformity Assessment (PCA) or alternately known as Pre-Export Verification of Conformity (PVoC) is a verification program designed to ensure that specific products meet requirement, technical regulation and standards set by a regulatory authority in the importing country.

In addition to the Pre-Shipment inspections required as part of the mandatory PCA process our team can also undertake tailored, client specific inspections to provide a report on the goods to be shipped.
