PROGRAM OBJECTIVES	 Protecting the agricultural sector against substandard pumps and pump accessory products that can either endanger public health, safety and the environment; and Prohibiting the entry of counterfeit products
VERIFICATION PROCESS	Request: Exporters intending to ship pumps and accessories to Ethiopia shall contact the SGS Affiliate in the Country of export and send Request for Certification (RFC) duly filled in along with Declaration of Conformity and Pro forma Invoice (PI), packing lists, as well as supporting documents proving conformity of the goods Verification: SGS shall proceed preliminary analysis of all documents submitted Verification of completeness of the documents; Verification of the compliance of the documents with the Ethiopian standards or Ethiopian Technical Regulations; Definition of certification requirements and method/s and communication to the client of the specific requirements for testing Attestation: Upon availability of all the required
	documents (Inspection report, test reports etc), SGS evaluates the documents against the relevant requirements stated in the Ethiopia Standards or Ethiopia Technical Requirements. A Certificate of Conformity shall be issued after

	The following documents are required by CoC issuance:
DOUCUMENTATION	(a) Request for Certification (RFC) and Declaration of Conformity(b) Final Documents (invoice, transport
	documents, packing list) (c) Laboratory test report of the product issued by "Approved Laboratories"
	(See Laboratory Testing) (d) Physical inspection with product photographs,
	(e) Information and pictures about product marking and labeling (for goods only requiring verification of product markings/labelling)
	Route B
	(a) Request for Certification (RFC)
	(b) Copy of the SoR or a SoR number for each concerned product
	(c) Commercial Invoice (pro-forma/final) and/or packing list
	(d) Information about product marking and labeling (copies of labels / prints) –if applicable-
	(e) Inspection Report (when applicable)
	A certificate of Conformity (CoC) should be issued to evidence compliance of the shipment
CERTIFICATE OF CONFORMITY (CoC)	 This document is required by customs clearance For goods shipped to Ethiopia without CoC will be subjected to systematic local inspection, sampling and testing by MoT upon arrival of the goods; and, clearance will not be authorized until satisfactory test results are available from ECAE sub contracted Lab outside Ethiopia
	A Non-Conformity report (NCR) is issued if verification activities such as testing or inspection show discrepancies versus the verification criteria.
NON CONFORMITY REPORT (NCR)	Exporters will be informed accordingly and given sufficient time to make the necessary corrections; if those are not or cannot be made, a "Non Conformity Report" will be issued.
LABORATORY TESTING	Laboratory testing is required to ensure that products meet safety and quality requirements. Only Test Reports from the following laboratories are accepted for the conformity assessment:
	 Laboratories accredited ISO 17025 for products of the related group of products by a full member of ILAC;



 Product certification bodies accredited for products of the related group of products by a full member of IAF/ILAC; SGS Laboratories and certification bodies accepted in UN ECE certification scheme (engines, etc.) Manufacturer laboratories, as long as all the following are fulfilled: Laboratory issued detailed and full Test reports according to the accepted standard, Manufacturer has his QMS certified (ISO 9001), Copy of Quality control report shall be provided (Routine tests) and shall demonstrate effectiveness of the conformity system, List of test equipment (name of the apparatus, name of related test, manufacturer name, model number) demonstrating the availability of the necessary equipment to perform the required tests
