# **QUALITY CERTIFICATES FOR GOODS**TO BE EXPORTED TO ALGERIA





# **THE PROGRAM**

Following the circular no 16/DGC/2009 from the Bank of Algeria dated 16
February 2009 and in accordance with the Algerian law 0404-2004, Articles 15 and 16 of the Decree no 05-465 and Article 26 of the Decree no 05-467, all regulated products to be imported into Algeria must be accompanied by a document of conformity, issued by an authorized Inspection and Certification Body recognized by the competent authority in the exporting country.

The regulated products are goods that may have an impact on health, safety and the environment as per Article 13 of the Decree no 05-465.

The document of compliance referred to as "Certificat de Contrôle de Qualité des Marchandises" in the note from the bank of Algeria is issued to testify that the goods are in compliance with the technical regulations and standards applicable in Algeria.

# **THE OBJECTIVES**

The key objective of the program is to make sure that all imported consignments of regulated products meet the mandatory quality, safety, and security requirements as per the

Algerian technical regulations and standards approved by IANOR (Institut Algérien de Normalisation).

The Conformity Assessment program is also expected to facilitate trade and avoid delays in customs clearance as well as potential losses that importers may be exposed to in case the goods fail to comply with the mandatory requirements.
