Certification for a sustainable world

The UN created 17 Sustainable Development Goals (SDGs) as an urgent call for action. For each SDG, the ISO has identified the standards that make the most significant contributions.

As an example, here is SDG 3 and some of the ISO standards that can help you to achieve it.

Many of the standards contribute to more than one SDG, such as ISO 26000 (social responsibility) that contributes to 16 of the 17 goals.



- ISO 11137, sterilization of health care products – radiation (various parts)
- ISO 13485, medical devices – quality management systems – requirements for regulatory purposes
- ISO 14001, environmental management systems – requirements with guidance for use
- ISO 20121, event sustainability management systems – requirements with guidance for use
- ISO 22000, food safety management systems – requirements for any organization in the food chain
- ISO 22716, cosmetics – good manufacturing practices (GMP) guidelines on GMP
- ISO 26000, guidance on social responsibility
- ISO 45001, occupational health and safety management systems – requirements with guidance for use
- ISO/PAS 45005, occupational health and safety management – general guidelines for safe working during the COVID-19 pandemic
