- Start: initial audit (stage 1-2)
- Year 1: first surveillance audit. The first surveillance audit must be completed within 12 months of stage 2's certification decision date
- Year 2: second surveillance audit
- Year 3: recertification audit. The certification has to be reissued before the end of the three-year certification cycle
