WHAT IS ISCC?

International Sustainability and Carbon Certification (ISCC) is an independent, multi-stakeholder initiative and leading certification system that supports sustainable, fully traceable, deforestation-free and climate-friendly supply chains.

ISCC has over 240 association member

ISCC provides clear chain of custody (COC) approaches with certification of the entire supply chain, from the raw material supplier to the brand owner receiving ISCC licensing to support their claims.

The scheme has site-specific certificates across material cultivation/ collection and processing, as well as final product distribution. Annual recertification is required.

ISCC's zero-deforestation policy ensures the protection of forests, high-carbon stock lands and biodiversity.

Main requirements:

- Quality management procedures, internal training and audits, and responsibilities
- Mass balance or physical segregation no overselling of certified products
- Traceability all deliveries must be traceable. Direct suppliers only

Among its services, ISCC developed the ISCC PLUS certification scheme.

WHAT IS ISCC PLUS?

ISCC PLUS is a sustainable certification scheme for bio-based, renewable and circular raw materials. It can help demonstrate your voluntary implementation of sustainability goals on a global scale. It also interconnects the entire supply chain, from cultivation, plastic recycling and electrolysis to plastic or chemical manufacturers and the final products of brand owners.

Originating in the biofuel sector, ISCC PLUS is closely related to the European Commission's Renewable Energy Directive (RED II) and is well-established to offer solutions that address sustainability requirements for numerous feedstocks and all markets.

ISCC PLUS can help you switch from a linear to circular economy, one that avoids incineration and landfill, and adopts recycling and reusing materials and components.
