

FUMIGATION OF CARGO IN WAREHOUSE

Cargo fumigation in warehouse is usually done under tarpaulin covers or by sealing the entire warehouse to avoid leakage of fumigant. Spraying the surrounding area of the lot with WHO approved pesticides are also performed for optimum results.

FUMIGATION OF CARGO IN CONTAINERS

Container loading is the most commonly experienced mode of export. The exported goods which are stuffed within shipping container are fumigated, and the container is allowed to be dispatched. A fumigation certificate is subsequently issued for treated contents and the container. Depending on the destination of cargo, the relevant fumigation standards are applied



FUMIGATION OF CARGO IN SHIP HOLDS

Pest infestation is common in cargo onboard vessels and ships. It is essential to take charge of the situation to eliminate the pests. In case of bulk cargo in vessel holds fumigation is done by placing perforated PVC pipes, through manholes and hold-top.



FUMIGATION OF ANTIQUES AND OTHER PRECIOUS MATERIAL

When insect infestation occurs in and other precious materials, like termites, woodborer etc. this is a serious problem and must be dealt effectively to avoid surprises SGS take care of antiques and precious materials. Common household treatment of pest control may destroy antiques and precious materials.



PACKAGING MATERIAL TREATMENT-ISPM-15

SGS Pakistan is registered for the treatment of packaging materials. International standards for phytosanitary measures (ISPM-15) is required to treat all packaging materials prior to export against insects and pest.
