INTEGRATED PEST MANAGEMENT SURVEY AND REPORT

- Visit of entire site / facility (Indoor & outdoor) and identification of critical points from where pest can invade into the premises.
- Identify surrounding conditions (nesting, foods and water etc) that initiate/ inhibit the spread of pests.
- Recommendations for preventive measures and their monitoring.

Reporting and Communication:

- IPM survey report will be prepared and shared to client for action.
- Layout plan (single line) for subject premises will be required / prepared to highlight the issues and to organize work properly.

Time Duration Required:

- 05 working day approx. will be required.
- Conducting survey, evaluation, report preparation and submission will be completed.

GENERAL INSECT PEST CONTROL SERVICE:

- Formulated material of Pyrethroid and Organophosphate (W.H.O. approved) will be used for residual and knockdown effect.
- All the infested areas should be accessible for effective treatment.
- Special care to be taken in sensitive areas.

- Special care to be taken in sensitive areas.
- Fogging / treatment to be carried out in areas where necessary as per requirement. Fogging usually done in closed areas.
- For effective control, advisable to treat the entire area in one go.
- Pyrethroid base oil sprays to be used in fogging for safety reasons.
- Dusting / baiting to be done in open areas as and when required.
- Other necessary pesticidal or non pesticidal treatments will be done to minimize the infestation level.

RODENT CONTROL SERVICE

- For effective control, advisable to treat the entire area in one go.
- Dusting / baiting to be done in open areas as and when required.
- Observation of the strategic point inside/outside areas (CCP).
- Placement of rodent station in safe places.
- Rodent Station to be numbered and appropriately labelled with warning signs to avoid any inconvenience (safety).
- Rodent Station/ Traps to be checked / replenished periodically as per

requirement.

- In outside area, single dose chemical may be used in rat burrows, rat runways and other infested areas.
- Dead rats to be removed, best buried subsoil by your trained Housekeeping staff.
- Layout- plan of the treated area will be prepared to mark the rodent stations.

BEDBUG TREATMENT

- Bed Bug Treatment in Mattress and Other Room related Items
- Items to be treated shall be placed in a room separately.
- All the materials will be covered in plastic sheet and will be fumigated with aluminum phosphide.
- Recommended to fumigate the room with PH3 for 48 Hours.
- Bed Bug Treatment in Rooms
- For bed bug treatment in rooms spraying activity will be performed.
- All windows and door must be airtight
- Ventilator/ air conditioners must be sealed prior treatment.
- Recommended exposure time for the room with spraying activity will be at least 06 hours.

- For all pest control measures, W.H.O. approved Pesticides/chemicals will be used.
- Services will be carried out under the supervision of Qualified Entomologist and/ or Technical Supervisors.
- All chemicals and formulations will be used safely as per HSE Rules.
- MSDS, related to chemicals used will be provided.
- Chemicals will be selected by identifying efficacy, resistivity against insects and same will be responsible for continuing or discontinuing of chemical.
- Proper/ safe spraying and fogging equipment will be used for optimum result.
- Treatment documents will be issued on monthly basis, if required.
- SGS will share safety and precautionary statements to Company which shall be followed by the Company's / client's representative present at the time of execution for personal, environmental and assets' safety of the Company/ client. Noncompliance of safety guideline may cause inconvenience and/or damage

to health, environment and/or assets for whatsoever will not be the SGS' responsibility.

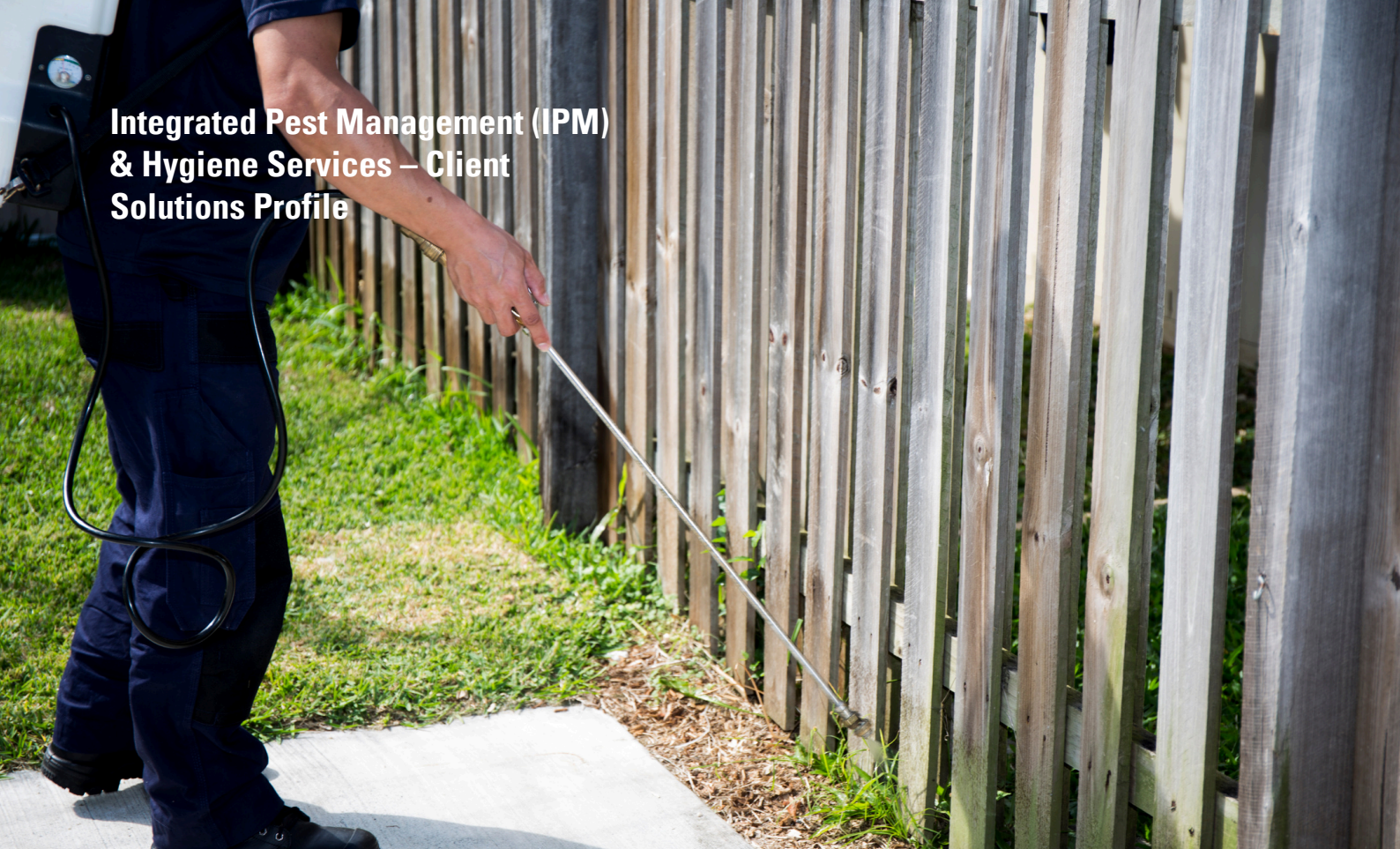
