3.1 Regulated Products

The Regulated Products have been classified into (2) classes:

- Process Manufactured Products: These products are characterized by susceptibility to change in their final nature as a
 result of probable changes in the nature of the raw materials used and the manufacturing process controls, whereby
 production is organized in batches. As such, these products are classified as high-risk products requiring frequent
 verification of conformity.
- Non-Process Manufactured Products: These products are characterized by low probability of change in the nature of the final product in comparison with a 'typical' sample of that product, thereby allowing for low frequency of testing for verification of conformity
