### 3. PRODUCT INFORMATION

#### 3.1 Regulated Products

The Regulated Products have been classified into two classes:

- **Process manufactured products:** These products are characterized by their susceptibility to change in the final nature due to potential variations in the raw materials used and the manufacturing process controls. Production is organized in batches. As a result, these products are classified as high-risk, requiring frequent verification of conformity
- **Non-process manufactured products:** These products are characterized by a low probability of change in the nature of the final product compared to a 'typical' sample of that product, allowing for a lower frequency of testing for verification of conformity
