The SQM license is valid for 3 years with annual surveillance inspection.

SQM can be applied for Vegetable Oils used for cooking, Fried Potato, Sugar, Olive Oil, Dates and its products, Saffron Product, Honey, Poultry Meat and Eggs, Cake, Biscuits, Arabic Coffee Enhancements, Milk, Fruit Juice, Drinking Water, Tea, Salt.
