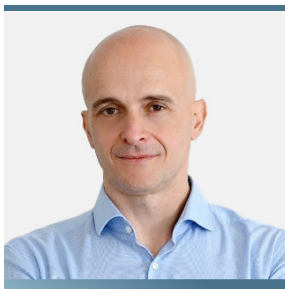

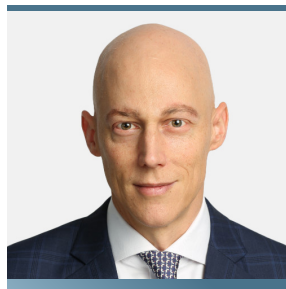

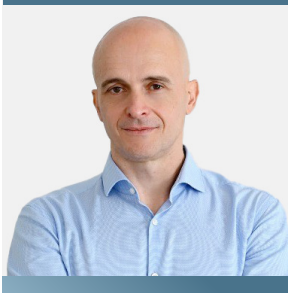
JAMES ROBERTS

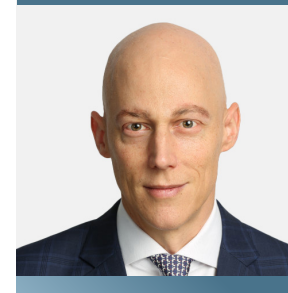
DAVID PLAZA
