Notification of MSPO Surveillance of **Palmgroup Holdings Sdn. Bhd.**

Dear Stakeholders,

This notice serves as a notification to all interested stakeholders that **Palmgroup Holdings Sdn. Bhd.** has applied to SGS (Malaysia) Sdn. Bhd. to conduct MSPO Surveillance audit within 15 days from the date of this notice issued. The audit will start **on 14-18 July 2025 (MS 2530-3-2 & MS 2530-4-1)**.
