Notification of MSPO Surveillance of **KLK Sawit Nusantara Sdn Bhd**

Dear Stakeholders,

This notice serves as a notification to all interested stakeholders that **KLK Sawit Nusantara Sdn Bhd** has applied to SGS (Malaysia) Sdn. Bhd. to conduct MSPO Surveillance audit within 15 days from the date of this notice issued. The audit will start **on 18-20 August 2025 (MS 2530-3-2) and 21-22 August 2025 (MS 2530-4-1)**.
