Notification of MSPO Assessment of IJM Plantations Berhad

This notice serves as a notification to all interested stakeholders that *IJM Plantations Berhad* has applied to SGS (Malaysia) Sdn. Bhd. to conduct MSPO certification audit within 30 days from the date of this notice issued. The audit will starts on 5th June 2018 and ends on 8th June 2018.
