Notification of MSPO Assessment of **Morisem Palm Oil Mill Sdn Bhd (Baturong Palm Oil Mill)**

This notice serves as a notification to all interested stakeholders that **Morisem Palm Oil Mill Sdn Bhd (Baturong Palm Oil Mill)** has applied to SGS (Malaysia) Sdn.
