Notification of MSPO Assessment of **Pamol (Estates) Sabah Sdn Bhd**.

Dear Stakeholders,

This notice serves as a notification to all interested stakeholders that **Pamol (Estates) Sabah Sdn Bhd** has applied to SGS (Malaysia) Sdn. Bhd. to conduct MSPO certification audit within 30 days from the date of this notice issued. The audit will start **on 6<sup>th</sup> November 2017 and ends on 10<sup>th</sup> November 2017**.
