Notification of MSPO Surveillance of Sarawak Oil Palms Berhad

This notice serves as a notification to all interested stakeholders that **Sarawak Oil Palms Berhad** has applied to SGS (Malaysia) Sdn. Bhd. to conduct MSPO Surveillance audit within 15 days from the date of this notice issued. The audit will start **on 8-10 December 2025 (MS 2530-3-2)**
