- Organised documentation & highly commitment towards certification.

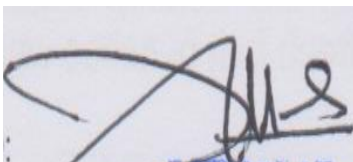
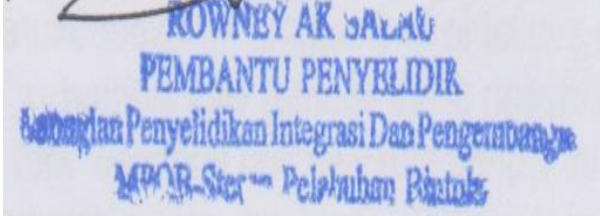
Important Observations and Opportunities for Improvements:
