# **INDONESIAN NATIONAL STANDARD (SNI)**

Indonesian National Standard (SNI) is a Standard set by BSN (National Certification Body) and applies in the territory of the Republic of Indonesia, it means every product which are manufactured or imported to Indonesia must comply with this standard. SNI are formulated by technical committees consisting of multi stake holders, including government, academics, industry and competent experts in their respective fields.

The main objectives of the Indonesian national standard (SNI) are:

- Increasing the protection of consumers, business executant, labor and other communities both for safety, security, health and the preservation of environment.
- Help to creating a smooth trade.
- Realizing fair business competition.

# INDONESIAN NATIONAL STANDARD (SNI) PRODUCT CERTIFICATION

Bring your product to the Indonesian market with confidence.

SNI Product Certification is an activity of evaluating the suitability of a product against the requirements specified in SNI through audit, testing and / or inspection activities. The conformity assessment activity is carried out by the Conformity Assessment.

Institution (Product Certification Institute and Test Laboratory - LSPRO) that has been accredited by the National Accreditation Committee (KAN). Products that are declared to fulfill the provisions in SNI are given a certificate of conformity (Product Certificate) as a written statement that the product has met SNI requirements.

There are several benefits from product certification activities, such as:

- Provide information to the parties concerned with the product, that product has met the product requirement;
- Enhancing acceptance level of product by customers
- Enhancing competitiveness of the product

#### **LSPRO SGS INDONESIA**

SGS Indonesia is one of accredited LSPRO to certify SNI by mandate of KAN (Komite Akreditasi Nasional) – the Indonesian Accreditation Body and referenced by Ministry of Industry, partner with SGS to bring your product to the Indonesian market with confidence.

To obtain product certification mark, the client shall make an application to LSPRO SGS Indonesia. In general, the process are as following:

# A. APPLICATION

At this stage, client request to make application for certification to product certification body, and the application will be reviewed by LSPRO SGS Indonesia for it adequacy and completeness.

# B. SELECTION (SAMPLING)

Determination of the characteristic of product to be assessed, referring to product requirement (SNI) and requirement for assessment and sampling.

#### C. DETERMINATION

Determination against applicable SNI may include testing, measurements, inspection, and auditing, to check whether products, are meet the product requirements

# D. REVIEW AND ATTESTATION

The review on audit result and testing result shall be performed to assess if product meets its requirements. After review is carried out, certification decision will be made to grant SNI mark of product.

# **SNI SCHEME**

There are three certification schemes applied by LSPRO SGS Indonesia, scheme 1b, scheme 4 and scheme 5.

# 1. SCHEME 1B.

This system includes testing, samples of the product are assessed for conformity. The sampling covers the entire population of product. A certificate of conformity is given to each product represented by the sample. This certificate system includes the following:

- Samples requested by the certification body
- Determination of characteristics by testing or assessment;
- Evaluation of the test or assessment report
- Decision
- License

# 2. SCHEME 4

This system includes testing and surveillance of samples from the factory or the market, or both. This certification system includes the following:

- Sample requested by the certification body
- Determination of characteristic by testing or assessment
- Initial assessment of the production process or the quality system, as applicable
- Evaluation of the test and assessment reports
- Decision
- License
- Surveillance of the production process or quality system or both organization
- Surveillance by testing or inspection of samples from the factory or the open market, or both

# 3. SCHEME 5

The system includes testing and assessment of the quality system involved. Surveillance of the quality system is conducted and samples of the product may be taken from either the market or the point of production, or both, and are assessed for ongoing conformity. This certification system includes the following:

- Sample requested by the certification body
- Determination of characteristic by testing or assessment
- Initial assessment of the production process or the quality system, as applicable
- Evaluation of the test and assessment reports
- Decision
- License
- Surveillance of the production process or quality system or both organization
- Surveillance by testing or inspection of samples from the factory or the open market, or both
